On September 28, 2020, the State Engineer received written petitions from Bradley J. Herrema, agent for IWS Basin, LLC, requesting a review of the cancellation of Permits 64977, 64978, 66400, 72700, 73428, 73429, 73430, and 74327 at a public hearing, pursuant to Nevada Revised Statute 533.395(2).

III. HEARING DATE

NOW THEREFORE, the hearing will begin promptly at <u>9:00 a.m. on</u> <u>June 15, 2021</u>, and with a second day to be scheduled at the hearing, if necessary. Due to restrictions on the operation of State of Nevada office buildings and limitations on public gatherings established under the state of emergency declared by Governor Sisolak on March 12, 2020, the Nevada Division of Water Resources will conduct the hearing through a video conference. Failure to appear at the hearing will result in an affirmation of the State Engineer's cancellation.
